I was reading a book the other day and came across the following statement: "So the way of Jesus is not about religion; it's about reality." I know that is a simple statement. One I've seen before. But this time when I read it, it seemed to explode in my mind and heart.

I recently saw this huge butterfly that was caught in a cobweb that was flapping his wings sporadically trying to get free of impending doom. Well, I couldn't watch it suffer, so I went over to rescue him and got him out, and he flew away! After seeing this, I felt compelled to research butterflies and I was surprised to find out that the butterfly lays eggs on leaves, then those become caterpillars, then those form into a chrysalis (which is similar to a cocoon) and then that becomes a butterfly! Did you know that? I did not realize that it was actually the eggs from a butterfly!



The amazing part about that is the DNA inside that caterpillar that is crawling around on the ground and climbing trees, it is designed to fly. It is designed to soar and has to go through the transformational process of the stages to get to that place.

That's so similar in our own lives. I don't know about you but I feel like my entire life has been turned upside down in the last couple of years. It has been brutal adjustments. We don't want the bad things that happen, but we can either let them destroy us when they do or we can adjust and figure out what we're supposed to do and how we're supposed to live our life now.

And to me, that's similar to the butterfly because its old self has to die off. It goes into this shell that it makes and supernaturally, the new butterfly comes to existence through the guided processes that God has designed inside that dark place wrapped up inside of that shell. Even the scientists said that they believe it's a type of resurrection that the old dies and the new is born. How similar that is how the Bible talks about the experience when we become born again!

One thing I thought about was how that caterpillar doesn't know it's going to be a butterfly as it's crawling around on the ground. Scientists say that the metamorphosis of a caterpillar to a butterfly is one of the most profound phenomena that happens in nature. And that word transformed, in scripture that was written thousands of years ago, means "to change from one form or shape to another and it actually means metamorphosis"! The more I study the similarities of a caterpillar going to a butterfly, being like our transformation and our relationship with God with our new nature and new life, I find it astounding.

As many of you know, due to the effects of Covid, I had to close all five of my studios and two years before that, my husband of 29 years, suddenly became ill and died. Two unexplainably difficult traumas to go through. So here I am in this place having to figure out how to transform in the midst of trauma, in the midst of a dark cocoon wrapped around me where it's intense and emotional and all completely different.

But one thing that I was inspired about with that butterfly is there is a moment when that outer shell is going to bust open. And that butterfly is going to come out of that cocoon with giant wings that it did not have only two weeks earlier! And all the sudden it's time for that butterfly to flap its wings and fly. Wow! Too bad it doesn't have any conscious awareness of what it just experienced! One thing I am about to bust out and do is launch my youtube channel, so be on the lookout for that too.

Matthew 5:23-24, "Therefore if you are presenting your offering at the altar, and there remember that your brother has something against you, leave your offering there before the altar and go; first be reconciled to your brother, and then come and present your offering."

This verse has a special place for me. It served as a guiding force to help me resolve a conflict in my life some years back.

Some 15 years ago, I went into business with several of my friends. We pooled our resources to open a restaurant and had plans to expand our business into several restaurants. We would each contribute not only monetary resources, but also act as the operators. We would pay ourselves a salary until such time as we decided to hire managers to oversee operations and we could remove ourselves from the operation and move forward in an ownership capacity only.

I managed the profit and loss responsibilities and worked closely with our accountant to ensure transparency. Before long I came across some transactions by one of the partners that were outside of normal business expenses. When I questioned the accountant, he was unsure about the transactions and noticeably uncomfortable. I decided to wait to speak to the partner about it until I had time to review the transactions more thoroughly. The partner heard about my questioning of the accountant and decided to call a meeting with the other partners, without me present. He advised that revenue was not sufficient to carry all 4 of our salaries and that he believed it would be in their best interest to buy me out. They agreed and advised me of such, later that week.

I remember feeling very hurt at first. He had misused company funds and I had caught him in the act. Why was I, now being punished? Did they not value my worth and honesty. I went from being hurt to being angry. Very angry. Three years went by. My anger hadn't hurt him. He didn't care that I was angry. I prayed, and I forgave him.

I let it go. We never spoke again but if I should run into him somewhere, I would speak to him cordially. I would ask about his family. I would be sincere.

Our life on this earth is short and should not be squandered trespassing against those who have hurt you. Jesus wants us to lay that down before we go to him. Listen to him. Don't keep taking the pill that is killing you.

The Who I Am Foundation with help from The Avon Park High School Rotary Club, want to change that. On September 30th, they will host a 5K Foster Care Pajama Run around the Mall in Downtown Avon Park. A portion of each entry in the race will be used to purchase a set of pajamas. On race day, these pajamas will be presented to ECHO.

The Who I Am Foundation, Inc is just one of many organizations The Avon Park Rotary Interact Club has supported with their Community Service Hours. Tracy Serdynski Stites shared, "These students are amazing. To date they have helped us create over 3500 free Healthcare Support Kits that have been distributed throughout Highlands County and over 1500 Foster Care Gift Bags distributed throughout Central Florida. They are a blessing to work with."

The Who I Am Foundation, Inc., a 501 c3 nonprofit based in Avon Park Florida, was formed in honor of Don Serdynski, lost to Covid on August 15th, 2020. He was admitted into the Covid Isolation Unit and soon after became non-verbal. At that time, no visitors were allowed into any Healthcare Facility. Tracy and her mom called every eight hours to get a status update from the nurses. Due to unusual circumstances, Tracy and her mom were given permission to go into Don's COVID Isolation Room, Tracy hung photos and her dad's favorite Florida Gator Championship Flag. If he opened his eyes for any reason, she wanted him to see photos of his loved ones and his beloved Florida Gators.

Steps to Build a Strong #9pmRoutine

One of the most common calls the Pasco Sheriff's Office is called to investigate are burglaries or thefts from cars. These are crimes of opportunity and convenience and are easily preventable. By simply removing all valuables from your car and locking it each and every night, you can reduce the risk of becoming a victim of this crime.

PSO created the #9pmRoutine as a reminder for citizens to remove all valuables from their vehicles and ensure that cars, windows and doors are locked before heading to bed for the night. This routine removes opportunity from the triangle of crime, which also consists of ability and desire. By removing just one of these aspects from the triangle of crime, the risk of becoming a victim is reduced. Here are some steps to include to build a strong #9pmRoutine and reduce elements of opportunity of crime:

Remove all valuables from your car. Create a habit of removing any valuables from your car when you park to ensure your items are safe. Never leave shopping bags or merchandise visible in your car while you're away. Lock expensive purchases out of sight in the trunk, or take them home immediately before continuing shopping trips.

Close and lock all windows and doors to your car and home. Many burglaries occur because a car or home was left unlocked, making it easy for criminals to steal their belongings. Thieves commonly test a door to see if it's unlocked and quickly move on when they're not able to enter easily. Enabling your car's alarm consistently, if equipped, is a good habit as well.

Be smart with your car and house keys. Easily accessible car keys are the simplest way for a criminal to steal a car. Always remove the key or key fob from your car when you get out, even if parking in your own garage. Leaving car doors unlocked can provide easy access to other ways to access your property, such as garage door openers. Never leave spare keys hidden within your car or near an entry point of your home, as criminals know where to look.

If you see something, say something! Be vigilant and report any suspicious activity you see to law enforcement immediately. Rapid reporting can help prevent your neighbors from becoming a victim. Be sure to provide the date and time you saw unusual activity and include as much information as possible to identify the suspect.

Taking a few minutes each night to remove valuables and lock your car and home can prevent you from becoming a victim in this crime of opportunity. The #9pmRoutine is a simple and fast crime prevention step that can have a big impact on crime!

An Act of Kindness: The Good Samaritan

How's Your Hearing?

I recently spent some time with an elderly woman who is very hard of hearing. On my part, I found myself having to repeat everything I said frequently, due to her hearing loss. Of course, on her part she was frustrated. Hearing aids are helpful, but her hearing loss is considerable.

We went shopping together and as we were going through the checkout line; another woman who was pushing her walker and dragging a roller chair approached us. She asked if she could just get the clerks attention to see if it was okay to leave the chair there while she finished shopping. I said of course, and she went ahead of us. However, my friend did not hear what she said and was immediately offended because she thought the lady was ignoring us and pushing her way ahead in the line.

Why is this story important? I'm glad you asked. In Matthew 11:15 (AMPC) Jesus was teaching the disciples and said, "He who has ears to hear, let him be listening and let him consider and perceive and comprehend by hearing." How important is it to hear with both physical and spiritual ears? My friend misses out on so much because of her hearing loss and she becomes increasingly frustrated and misinterprets events that are happening all around her. She is unable to consider and perceive because of her hearing.

I wonder when we are not listening with an ear to hear the Lord through His Word and fellowship with him, do we greatly diminish our understanding and perceptions of those things that happen around us either through events or relationships?

The ministry of the Holy Spirit is to lead us and guide us into truth (reality). His fellowship provides clarity. Jesus said in John 10:27 AMPC "My sheep that are my own hear and are listening to MY voice; and I know them, and they follow me." If we don't have an ear to hear as we are so often exhorted to do in the scriptures we will miss out on direction, we'll miss out on fellowship and when we miss out on fellowship, we misunderstand God's heart. When we misunderstand God's heart, we can become offended, and the result is a disconnect with Him in our relationship. The same principle works with natural relationships, friends, family, co-workers and so on.

My friend's perception of the events taking place in my story above was skewed, through no fault of her own. I wonder how many events we misinterpret because we don't have ears to really hear and discern the truth. In James 1:19 (AMPC) it says, "Understand this, my beloved brethren, Let every man be quick to hear (a ready listener) slow to speak, slow to take offense and to get angry." This tells me that listening with an ear to hear, even beyond one's tone of voice facilitates better communication and understanding.

Have you ever been talking with someone and instead of really listening you are already trying to wait for them to stop speaking so that you can give your thoughts on a matter? Most likely you missed out on really hearing, considering, perceiving, and comprehending what was said. Surely this is why we are exhorted to be swift to hear but slow to speak, as we may have missed entirely what was truly being said. I encourage you today, slow down pray for an ear to hear, not only from the Lord but with others.

We continue to make it easier for you to access our programs and benefits. Our website offers a convenient way to apply for benefits online.

Here are 5 ways you can apply for benefits using ssa.gov.

- Retirement or Spouse's Benefits You must be at least 61 years and 9 months and want your benefits to start in no more than 4 months. Apply at www.ssa.gov/retirement.
- Disability Benefits You can use our online application, available at www.ssa.gov/benefits/disability to apply for disability benefits if you:
 - Are age 18 or older.
 - Are not currently receiving benefits on your own Social Security record.
- Are unable to work because of a medical condition that is expected to last at least 12 months or result in death.
- Have not been denied disability benefits in the last 60 days. If your application was recently denied, our online appeal application is a starting point to request a review of the determination we made. Please visit www.ssa.gov/apply/appeal-decision-we-made.
- Supplemental Security Income (SSI) SSI provides monthly payments to adults and children with a disability or blindness who have income and resources below specific financial limits. SSI payments are also made to people age 65 and older without disabilities who meet the financial qualifications. If you meet certain requirements, you may begin the process online by letting us know you would like to apply for SSI at www.ssa.gov/ssi. If you do not have access to the internet, you can call your local Social Security office to make an appointment to apply.
 - $\bullet\ Medicare-Medicare\ is\ a\ federal\ health\ insurance\ program\ for:$
 - People age 65 or older.
 - \bullet Some people younger than 65 who have disabilities.
 - People with end-stage renal disease or Amyotrophic lateral sclerosis (ALS).



Labor Day – The Industrial Revolution

The Industrial Revolution modernized the United States and Canada during the 19th century. As people enjoyed steady employment, they compromised their rights in the workplace. Longer work hours and pay cuts were imposed; U.S. labor groups began protecting themselves by unionizing. In Canada, unions were illegal until 1872, when thousands of Ottawa laborers marched to Prime Minister John MacDonald's home.

That year, Canada wiped the anti-union law from its books and the march became an annual Canadian tradition. In 1882, Toronto labor officials invited an American union leader, Peter J. McGuire, to Toronto's labor celebrations. McGuire was so impressed that he suggested a workers' parade to New York City Central Labor Union.



He chose September 5th as the date because it filled the long void between July 4th and Thanksgiving. Coincidently, that same year a machinist from Patterson, New Jersey, Matthew McGuire, also proposed a laborers' celebration. On Tuesday, September 5th, 1882, thousands of New York City laborers marched from City Hall to Union Square. They gathered in Reservoir Park for an afternoon of picnics, concerts and speeches, rallying for an eight-hour workday.


Two years later, the Central Labor Union moved the parade to the first Monday in September. They also encouraged all U.S. cities to follow New York's lead and march for the workingman's holiday. For many, the choice was to either spend the day at work or march without pay. That began to change when Oregon became the first state to legalize the Labor Day holiday in 1887. Other states, including New York, soon followed.

It took a political disaster to put Labor Day on the national calendar. In 1894, railway workers in Pullman, Illinois, went on strike to protest wage cuts. President Grover Cleveland faced pressure to end the demonstrations and sent 12,000 federal troops to break the strike and violence erupted. Two strikers were killed, and Cleveland's harsh methods made headlines. In an attempt to appease the nation's workers, he signed a bill to make Labor Day a federal holiday. Cleveland still lost that year's election.

America's workers continued to gain power through the 1950's when over a third of all labor forces were unionized. Labor Day had become a time to rally workers for safer conditions, fair pay, and benefits. But in the second half of the 20th century, the U.S. labor force diminished, many factories closed, jobs were outsourced to other countries. Today, workers still parade through blue-collar neighborhoods on Labor Day and speeches unite the ever-dwindling labor force, but the day's true call has quieted. For now, most Americans leisurely enjoy the holiday as summer's last bow.

12 Skin Cancer Myths and What You Need to Know, Part 2

Last month we began our discussion on twelve skin cancer myths.

This guide is to separate fallacy from reality and help you choose the right course of action. Let's continue to explore some of the common facts and myths about skin cancer and include some tips to reduce your risk. Here are myths 7 - 12.

Myth 7: Melanomas never happen to those less than 30 years old.

I was told in my dermatology training that a melanoma in a teenager was quite rare. Yet ten years later, in one six-month period, I had a 14 and a 15-year-old with Stage 4 melanoma.

Melanoma is the most common form of cancer in young adults aged 25-29 and the second most common form of cancer among people. It is also increasing faster in women ages 15 to 29 than in men in the same age group.

You should check your skin monthly and be alerted to changes in the number, size, shape, or color of spots on your skin or sores that do not heal. Pay special attention to moles—especially moles that have recently changed, bled or itched. And get a complete skin exam yearly or more often if you or family members have a history of skin cancer.

Myth 8: A melanoma is always easy to treat.

Treatment can be relatively easy when you detect a melanoma early. When a melanoma has grown and spreads to the liver, bone, brain, or digestive system, it can require more invasive and long-term treatments. Melanoma may be fatal without proper therapy.

If you have an odd-looking or suspicious mole that has changed in size or color, especially one that itches or bleeds, get it checked out. If you have had three or more blistering sunburns in childhood, you have a higher risk of melanoma.

Get an annual skin cancer screening to identify cancer in its early stages. If you have a melanoma, the five-year survival rate if detected and treated before it spreads is almost 100 percent.

Myth 9: Having a base tan will protect you against melanoma.

A tan is simply a "controlled burn." If your skin changes color in response to sun exposure, it indicates damage to the DNA of your skin cells. A safe base tan or a tan that prevents sunburn

In trying to protect your cells, your body sends melanin, or pigment, to the surface of your skin. The body senses that UV damage is occurring. With a sunburn, it becomes more than the skin can manage and it can't be repaired. You may get color on your skin, but it will be at the expense of your health. You may develop unsightly lesions, wrinkles, and skin cancer. Any level of UV damage is harmful to your skin and may increase your risk of skin cancer. Key actions to take to adequately protect your skin are the four S's: shade, sunscreen, skin coverings, and sunglasses.

Myth 10: Tanning beds don't pose a skin cancer risk.

Not true. Tanning beds emit the same harmful UV rays as the sun, and in greater amounts. According to the Skin Cancer Foundation, indoor tanning beds can emit 10 to 15 times more UV radiation than the sun at its peak. Exposure to the ultraviolet light from tanning beds can be harmful to the skin in a number of ways, including premature aging, wrinkles, sunspots, or freckles. One in every five Americans who frequent tanning booths may get skin cancer, including melanoma. The use of tanning beds and sun lamps is hazardous because the UV radiation they deliver can damage your skin and should be avoided. Using sunless tanning products is a prudent alternative.

If you regularly use a tanning bed before age 35, it increases your risk of developing melanoma by 75%. Indoor tanning is linked to about 6,200 cases of melanoma in the United States every year.

Myth 11: Makeup with SPF is all you need.

A broad-spectrum sunscreen of SPF 30 or higher is optimal, but most cosmetics with builtin sunblock have a SPF of only 15. In order to keep your skin safe against harmful UV rays, you will need to double up on the protection. After washing in the morning, you can apply moisturizers with SPF 30 or more and re-apply sunscreen as the day goes on and if you have more sun exposure. Don't forget about your lips. Make sure you apply lip balm or lipstick with a SPF of 30 or higher.

Myth 12: Putting on sunscreen is always effective.

Wrong. It is not effective unless applied correctly. Here are 4 key tips from the American Academy of Dermatology:

Always apply sunscreen before going outdoors. Remember that it takes approximately 15 minutes for your skin to absorb the sunscreen and protect you. Do not wait until you are in the sun to apply sunscreen; your skin is unprotected and can burn.

Use enough sunscreen. Most adults need about 1 ounce — or enough to fill a shot glass — to fully cover their body. Rub the sunscreen thoroughly into your skin. Reapply every 2 hours.

Apply sunscreen to all bare skin. Remember your neck, face, ears, tops of your feet and legs. For hard-to-reach areas like your back, ask someone to help you or use spray sunscreen. If you have thinning hair, either apply sunscreen to your scalp or wear a wide-brimmed hat. To protect your lips, apply a lip balm with a SPF of at least 15.

To remain protected when outdoors, reapply sunscreen every two hours, or immediately after swimming or sweating. People who get sunburned usually don't use enough sunscreen, don't reapply it after being in the sun, or use an expired product.

Most people under-apply sunscreens, using ¼ to ½ the amount required. Using half the required amount of sunscreen only provides the square root of the SPF. If you do not apply enough sunscreen or you apply your sunscreen incorrectly, it will result in a lower SPF than the labeled protection level. A half application of an SPF 30 sunscreen only provides an effective SPF of 5.5!

Parents and caregivers need to make sure that sunscreen is applied in liberal amounts to protect the children and the elderly. Children can be taught at an early age, with supervision, to apply sunscreen properly. Again, make sure you and others under your care wear a hat, sunglasses, and sun protective clothing, especially during peak sun hours. And if you go swimming or sweat a lot, it's a good idea to reapply the sunscreen.




